## Note

The Company was in compliance with Clause 49until the death of an Independent Director in February 2013 and resignation of an Independent Director in June 2013.

While efforts were on to induct new Independent Directors, during April 2014 SCM Soilfert Limited made an Open Offer and Zuari Fertilisers & Chemicals Limited made a Competing Offer in May 2014 for acquisition of equity shares of the Company from the public shareholders.

As per Regulation 24(3) of Chapter IV of SEBI's SAST Regulations, 2011, Company could not induct any new Director during the pendency of competing offer.

Further, Zuari Fertilisers & Chemicals Limited announced another Open Offer on 5.12.2014 for acquisition of equity shares of the Company from the public shareholders which was completed during quarter ending 30.6.2015.

In view of the above, the Company is in the process of identifying and appointing appropriate number of Independent Directors on the Board of Directors of the Company.
